**Project Scope:** This Contract installs active grade crossing signalization equipment on Lincoln Avenue, between Port of Tacoma Road and Thorne Road, and Port of Tacoma Road near Lincoln Avenue. The project adds two cantilevered LED flashing light structures with shoulder mounted flashing LED lights, bells and gates to each of the crossings. Both crossings will inter-tie into the existing traffic lights at the intersection of Lincoln Avenue and Port Road. Project includes associated ADA sidewalk and utility work, all in accordance with the attached Contract Plans, these Contract Provisions, and the Standard Specifications.

The Federal Small Business Enterprise (FSBE) goal for this work is 7%.

**Estimate:** \$2,100,000.00
